VENDOR INFORMATION & RULES

- 1. Entry forms must be received by April 18**
- 2. Booth Prices: All are 10x10 spaces**
 - Retail Vendor Booths \$20 and an item donated to the silent auction, 10x20 space \$30
 - Used Tack Spaces \$10 (you keep all of your sales, not consignment)
- 3. Your booth fee will be refunded only if spaces fill prior to receiving your application, or the event is entirely canceled. Please note the Rain Date of May 3. No refunds once you are accepted or if you are unable to attend rain date.**
- 4. Booths can be set up between 11:00 am to 1:45 pm (for other times please contact the coordinator)**
ALL VEHICLES MUST BE REMOVED FROM VENDOR AREA BY 1:30 PM
- 5. Please do not break down until approximately 6:00 p.m. For the safety of visitors, vehicles cannot be allowed in vendor area after setup without approval from staff.**
- 6. Vendors should provide their own display equipment, tables, and chairs. Tents are allowed.**
- 7. The following items are acceptable: TACK, art, crafts, horse/farm/pet related items, barn related equipment, etc. All equine tack should be safe and in good repair. Please no non-equestrian clothing/shoes. Booths should be neat and orderly. All items should be priced CLEARLY. We reserve the right to ask you to remove offensive, unsafe, unrelated, or restricted items from your booth.**
Saving Grace staff reserves the right to reject any application or ask any booth/person to leave for violation of these rules, disruptive or unsafe conduct, or disrespect toward staff/volunteers/vendors.
- 8. Exhibitors are responsible for their own business transactions, including the charge of sales tax and event insurance.**
- 9. Saving Grace Farm and all volunteers or affiliates of the Horse Lover's Jubilee are not responsible for lost, stolen or damaged items. Vendors are responsible for all possessions and should take precaution to protect valuables if leaving their booth at any time. If you need someone to watch your booth, please ask Event Staff.**
- 10. Space assignments will be given to vendors upon arrival.**
NO ALCOHOL, DRUGS, ILLEGAL OR CONTROLLED SUBSTANCES ON SITE AT ANY TIME
